Dear Parents and Guardians,

Sub: Fee Structure for Academic Session 2022-23

Warm Greetings from M. P. Birla Foundation Higher Secondary School! We hope that you and your family are safe and healthy. As the propensity of the pandemic is found to subside and we move towards a semblance of normalcy, we thank you for your cooperation throughout the difficult times since March 2020 during which, we on our part, along with our dedicated teachers and other coworkers and cooperation received from you have left no stone unturned to facilitate the continued and holistic learning process that our students deserve and have been accustomed to for so long.

In the same spirit, we move ahead with our plans for the Academic Session 2022-23 and with that purpose in mind the fee structure has been finalized which will be applicable for all students for the academic session 2022-23. You will find the fee structure applicable to your ward in the attached document.

We also draw your kind attention to the order dated December 17, 2021 in WPA 5890 of 2020 and other related matters passed by the Hon'ble Division Bench of Calcutta High Court. By the said order, the Hon'ble Court has passed directions, inter-alia, that the school shall intimate to all parents/guardians an estimate of fees and additional charges for compulsory facilities to be provided and service to be rendered as well those of optional facilities. The Hon'ble Court has further directed that all students (except those who are to appear in Board Examinations) have to be readmitted into the school from 15th March 2022 and that such readmission will be done only if the fees and charges are paid by the said date.

Accordingly, all guardians who wish to continue their ward's education at M. P. Birla Foundation Higher Secondary School beyond the current Academic Session are required to respond to this notice and submit in the School office **a filled in and signed copy of the enclosed CONSENT FORM FOR READMISSION (CFR)** by any of the two methods: (1) through mail to adm.n.mpbfhss@gmail.com and attaching scanned copy of the signed statement (in pdf or jpeg format); or (2) submitting the signed hard copy physically at the DROP BOX kept at the school gate. The last date for submission of the said statement (CFR) is **February 25, 2022**. Please note that for those willing to continue their wards' education at M. P. Birla Foundation Higher Secondary School, it is **COMPULSORY** to submit the statement. **Please note that for such readmission the school will not be charging any extra sum of money from its existing students.**

In case any parent/guardian does not wish to continue their child at M. P. Birla Foundation Higher Secondary School, they are requested to visit the school and contact the school office to clear the previous dues, if any and as applicable to them, on any working day between March 15, 2022 and March 25, 2022. Those who wish to continue with this school and have part of their fees for the academic year 2021-22 still lying unpaid, may contact the school office on any working day between February 28, 2022 and March 9th, 2022 to know their outstanding amount and clear the same. If any part of the School Fee for a child remains unpaid after March 15, 2022 or if the statement in the enclosed format is not received by the school, it will be presumed that the guardian/parents of the child are not willing to continue him


or her at this school from the next academic session, and appropriate steps will be taken in terms of the rules of the school.

The School will extend all administrative support to any parent/ guardian who would like to withdraw their ward before the next session. Academic progress for the session 2021-22 will not be hampered, keeping in view the academic needs of the concerned pupil.
